At 5:12 p.m. Mr. Duarte announced the public hearing is now open and that this is the time to hear any protest, comments and questions from interested person.

Mr. Duarte stated we will now hear public comment.

Public Comment: Howard Tounget commented about the costs for Valley-Wide in this CFD process, and stated he has seen the direction from LAFCO regarding Menifee and questioned by the District is continuing this process, Mr. Tounget also questioned the costs to the taxpayers regarding this process.

At 5:16 p.m. Mr. Duarte stated the public hearing is now closed.
